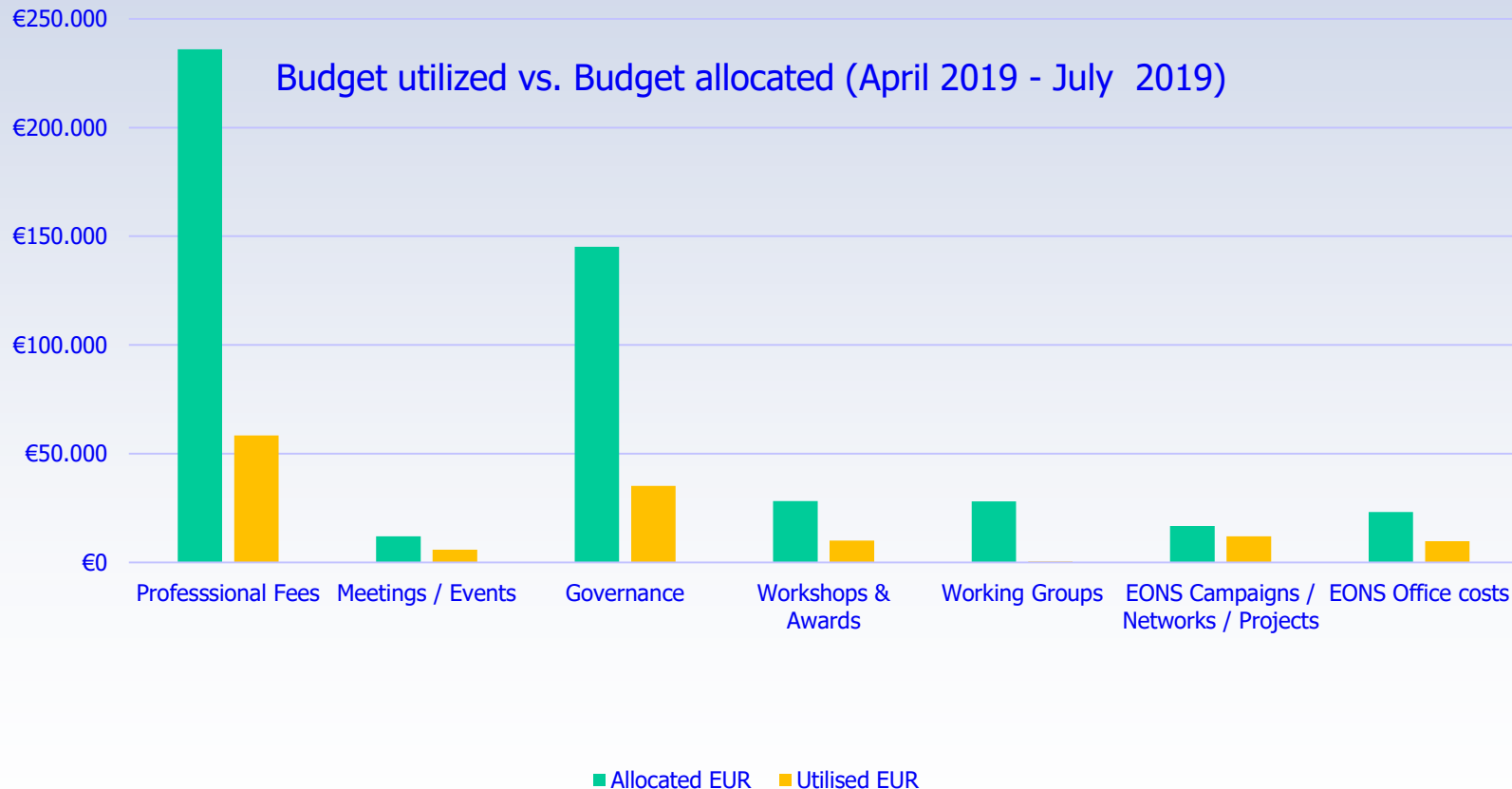

- RECaN phase 3 – Recognition of Cancer Nursing on European level
- 2 Task Groups
 - ❑ Safety (Occupational & Patient)
 - ❑ Education (Common Training Framework - Recognition)



Advocacy WG

➤ TG Safety

- ☐ Survey launched at EONS 12
- ☐ To attending participants (available in English and Spanish)
- ☐ Will also be online after EONS 12 for 1 month
- ☐ Not scientific aim – it is an advocacy tool and will guide on further steps
- ☐ Constitutes of our own questionnaire focusing on safety around cytotoxic drugs as well as “Hospital Survey on patient safety”- more broad focus



Advocacy WG

➤ TG Safety

- ☐ During autumn planning for a project to assess how AE's are reported - using an adopted version of Global Trigger Tool
- ☐ Will be done by Advocacy WG members in different countries
- ☐ Exploring the possibility to involve some other countries
- ☐ Reviewing 20 health records each
- ☐ Aim is to describe prevalence rate, level of harm and the preventability of AE's reported in different countries in Europe
- ☐ Focus is patient safety



Advocacy WG

➤ TG Safety

- ❑ Results from RECaN phase 2 – continuous work on safety - leading to a position paper or “white” paper on safety
- ❑ Collaboration with ECCO and ESMO – discussions ongoing
- ❑ EONS represented in a European project, with members from Research - and Advocacy WG as well as Lena Sharp
 - ⇒ Commission’s Directive on Cytotoxic Materials (CMD) approved last year
 - ⇒ commitment to undertake more research to understand the impact of cytotoxic materials on the health workforce



Advocacy WG

- ❑ By the end of 2020, data set of how education is regulated for all EONS member countries
 - Table covering several items re to Ca Nursing specialization and recognition (filled in by WGs' members = 17 countries) + missing countries
 - Matching with data from ESNO-survey (European Specialist Nurses Organizations)



Advocacy WG

➤ TG Education - CTF

❑ Explore in parallel how EONS Cancer Nursing Education Framework can be “translated” in a Common Training Framework

- To obtain EONS Education Framework recognized as a common set of knowledge, skills and competencies by 1/3 of the EU member states (10 countries)
⇒ automatic recognition
- To compare EONS Education Framework with the European Qualification Framework (EQF) in collaboration with Education WG
- Uptake of EONS Education Framework in OECI standards for accreditation and specialized cancer nursing included as a requirement for future European CCCN

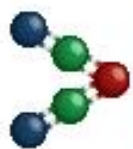
The education working group will support the overall EONS strategic goals by:

The “Roadmap” to this Vision...

Listen to the societies on how to Improve the collaboration between the membership and seek ways to engage more with member societies that are currently less active.

Establish collaboration with other International Nursing Societies and Health Organizations – ICN (International Council for Nurses) and WHO (World Health Organization).

Engage with f-t-f meetings with all the stakeholders/key players in cancer (e.g. current and future collaborators including pharma).

Grow the society further by attracting new members and re-engaging older ones – if we are active in the WHO Europe region then it leaves us with 22 countries which could potentially join the society.

Social “face” of the society (social output) – As a charity I feel we are not doing about this – this requires engagement with the public (i.e not just patients).

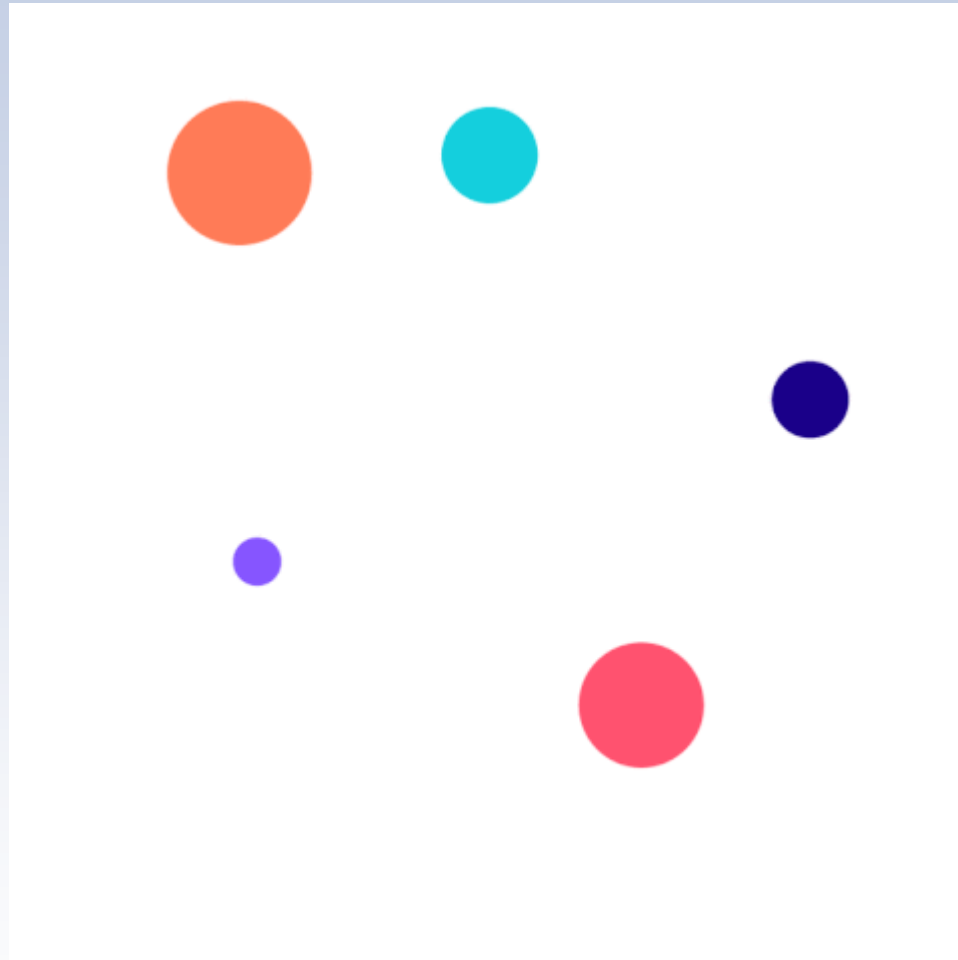

EONS Foundation

- Pursue the possibility of establishing the “EONS Foundation”
- Clearly positive outcomes for pursuing this
 - More flexible organization
 - More likely to attract funding (e.g donations)
 - Releases the Society from the constant pursue of funding allowing more time to materialize its strategic mission
 - In the medium and longer term provide financial *Stability* and *Sustainability*





Placing EONS at the centre of Cancer Nursing



Becoming a Leading Nursing Organization

- We have an enormous pool of experts across cancer types, populations, and treatments and yet we don't produce practice guidelines that should set the standard for cancer nursing practice in Europe.
- There are so many areas we should be making a standpoint - This can be done through the creation of a new WG!



Policy – proceed to RECaN Phase 3



- ➡ Decide/implement on a pathway to make the recognition possible based on a more concrete time-frame
- ➡ ALL WGs need to be included
- ➡ Engage the full potential of our partners:
