### **I would like to become EONS President-Elect because:**

I have the privilege of being a member of the EONS Board as a representative of Young Cancer Nurses since May 2021. Leading this inspiring group of nurses, I have diligently worked in collaboration with the EONS Board and working groups, National Societies, stakeholders and associations to ensure their perspectives make it to the core of EONS work. I envision my candidacy for the EONS President-Elect as a continuation of my current role, but also as an opportunity to further expand my contribution to EONS CARE strategy

My 15 years in clinical practice alongside my professional studies and current involvement in several research and policy initiatives have given me a deep and broad insight of the needs that govern cancer care. This has allowed me to develop deep understanding of the challenges and realities that clinical nurses working in direct patient care face.

**My aims during my term as President-Elect of EONS would be:**

**The skills and experience that I would be able to bring to the role are:**

What I bring to the role includes an extensive experience from partnering and collaborating closely with policy makers, Ministries, Societies, Associations, patients and patient advocates for a number of issues that pertain the profession. Just recently, In collaboration with my Society, I have worked on developing the first specialization course in Croatia, following actions initiated by EONS in 2022.

I will draw on my clinical, research and academic skills in the field of cancer nursing to contribute to the advancement of the profession in Europe but also to the interest of those affected by cancer for care that is provided at the time that is needed, it reflects the peoples' needs and it is one of the highest quality from prevention to end of life care.

- To encourage nurses to work together, not only for patient care but also for educational opportunities and research projects.

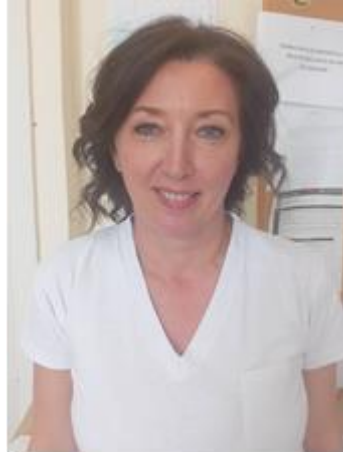
**The skills and experience that I would be able to bring to the role are:**

My every day practice consists of administration of disease-specific therapies (chemotherapy, new targeted therapy, immunotherapy and novel therapies) as well as assessment and treatment of disease-related symptoms and therapy-related toxicities and end-of-life care (supportive and palliative care). This valuable and fulfilling work must take place in a healthy environment with a high degree of safety and must be evidence-based. In the last 27 years, I have always pursued the goal that these conditions are also found in clinical practice. Unfortunately, there is still a lot to do. Therefore, almost two years ago, I sought the way to EONS and became a member of the Education Working Group. I did this because, among other things, I consider the EONS Cancer Nursing Education Framework as well as programmes such as TITAN or Target to be incredibly important steps for clinical practice. I really wanted to be part of this and help to shape it. I also found an unbelievable sense of belonging with international colleagues. In these two years, I have been able to increasingly contribute, e.g., with the help of my multi-professional skills as an interface to the ESMO Patient Guidelines. In autumn, I will now be able to help run the 14th masterclass in oncology nursing as an advisor. These are very exciting times. It seems to me personally and professionally that now is the right time to take the next step and use the opportunity to apply for the EONS board. There I hope to achieve even more for clinical practice and the work with patients.

### ***My aims during my term on the Board of EONS would be:***

- Work with all working groups and board members to support the implementation of the EONS strategy.
- Visibility, audibility and palpability of oncology nursing in all relevant committees. Wherever oncology nursing is discussed, EONS must be at the table.
- To always represent the voice of clinical practice at EONS and across Europe.
- To ensure the safety of oncology nurses in their workplace.

- To initiate and contribute to the development of evidence-based educational initiatives for clinical practice.
- To share my experience with Young Cancer Nurses.

**The skills and experience that I would be able to bring to the role are:**

I can bring to the EONS Board skills and experiences that have been developed over 27 years in my professional career: as an oncology nurse, as a pedagogue and as a scientist working in clinical practice.

As a nurse, I have 27 years of continuous professional experience in oncological and haematological nursing. Of these, I have been campaigning for the improvement of working conditions for oncology nursing in the German-speaking countries for 25 years. Examples of this are the safe application of cytostatics and the certification of comprehensive cancer centres in Germany. In 2007 I started to build up my role as clinical nurse specialist for patients with multiple myeloma and cellular therapies, first in Freiburg, Germany, then in Zurich and now in St. Gallen, Switzerland.

As a pedagogue, I started supervising nursing students in the clinical area 25 years ago. After studying pedagogy, I was responsible for the theoretical and practical training of oncology nurses. This training was based on the EONS framework and was accredited by EONS. For over 12 years I have also been a lecturer at various German and Swiss universities. My main topics are patient education, symptom management, advanced nursing practice and occupational safety with cytotoxic drugs. One of my seminars is based on the module "Cancer Care and Safety" of the EONS framework. I have been offering courses on safe administration of chemotherapy throughout Germany for five years. In addition, I have written more than 50 publications on oncological topics in German nursing journals and have given presentations at all relevant national and international oncological nursing conferences, e.g., at EONS, EBMT and the International Myeloma Society meetings. All this work has resulted in a worldwide network, which is very useful for my daily work.

As a scientist working in clinical practice, I am committed to good symptom control. It's about bringing science into clinical practice, making it explainable and developing symptom management interventions in the field. But it is equally important to bring clinical practice into science where there is no evidence.

Not to forget my personal skills. As a father of four children, I have learned to be calm and cool-headed and to find solutions in a team that fit for everyone.

**I would like to become EONS Board member because:**

I joined the EONS Education Working Group in 2020 and I am also a member of the steering group for the European College of Cancer Nursing. I bring significant clinical and academic experience in cancer, palliative and end of life care and education. Throughout my career, I have been committed to enhancing cancer, palliative and end of life care through my education, scholarship and research activities focused on workforce development and a range of education opportunities (workplace learning, non-accredited workshops, on-line learning, university accredited) for all nurses providing care to people affected by cancer and their families in non-specialist and specialist clinical services/settings and roles. My work includes working with government, charitable and professional organisations creating UK-wide career pathways, core cancer capabilities and education frameworks for the cancer workforce.

As an EONS Board Member, I would use my knowledge, skills and expertise to raise the profile of cancer nursing and promote careers in cancer nursing. I would promote the development of the cancer nursing workforce across Europe, supporting and promoting EONS and the working groups, and the EONS Education Framework, to incrementally and progressively develop the level of theoretical and practice-based knowledge and skills of cancer nurses, from the early career cancer nurse through to the enhanced, advanced and consultant (expert) level cancer nurse, to enable them to deliver holistic person-centred care for individuals and communities, appraise and implement evidence-based nursing care and, progressively contribute to, and lead the recognition and status of cancer nursing through service innovation, research and education.

To achieve this, I am keen to work collaboratively with Board and Working Group members to lead, steer and enhance the role and development for all cancer nurses across Europe, promoting and ensuring equity of opportunity and standards, and, ultimately, enhancing the experiences and outcomes for people affected by cancer.

**My aims during my term on the Executive Board of EONS would be:**

As part of the EONS Board, I will work strategically with Board and Working Group Chairs and members to:

- Promote cancer nursing as a career across Europe
- Bring together our collective expertise to work strategically to establish education standards and to support the development of cancer nursing education, promoting continuing professional development opportunities for the nursing workforce at all levels along a career pathway
- Establish a career pathway which incrementally and progressively develops the level of theoretical and practice-based knowledge and skills of cancer nurses using the EONS Education Framework to signpost a range of workplace learning, continuing professional development activities, EONS masterclasses and, where available, university accredited postgraduate modules and courses, to structure the knowledge and skill development of nurses, evidence their learning and plan to achieve the career aspirations of nurses across Europe
- Promote and support opportunities to collaborate on developing the evidence base for cancer nursing through research and scholarship

**The skills and experience that I would be able to bring to the role are:**

Throughout my clinical and academic career, I have worked at regional and national levels within the UK to widen access to cancer, palliative and end of life care continuing professional development opportunities, and promote inclusion of these subjects in pre-registration curricula for nursing and allied health professionals. I have widened access by developing e-learning materials; securing education funding; establishing collaborative partnerships; and publication of high-quality resources.

I am a member of the RCN Cancer and Breast Care Forum Steering Committee and lead author for the RCN (Royal College of Nursing) Career and Education Framework for Cancer Nursing; a framework which uses the EONS Education Curriculum for Cancer Nursing.

This document provides a framework of knowledge and capabilities for pre-registration student nurses, the supportive level workforce and all registration level nurses providing cancer care, distinguishing levels of practice for those in specialist services practising at registration, enhanced, advanced and consultant levels. In 2022, the RCN Framework was updated aligned to the revised EONS Education Curriculum and received EONS endorsement. Using the RCN Framework, I and colleagues developed the ‘Cancer Nursing Careers’ e-learning programme. Launched in March 2020, this series of e-learning modules

are accessible to health professionals across the United Kingdom. <https://www.e-lfh.org.uk/programmes/cancer-nursing-careers/> These e-learning resources are also currently being used in the pilot pathway for registered nurses developed by the European College of Cancer Nursing. A version has also been created for pre-registration nursing and allied health professional learners as part of the ACCEND (Aspirant Cancer Career and Education Development) programme.

Working at a UK-wide level with government funding, I am a Steering Group member for the ACCEND programme, leading workstream 5 developing the 'Career pathway, core cancer capabilities in practice and education framework' for the nursing and allied health professions workforce across 4 UK nations. This was published in January 2023 and is available at: <https://www.hee.nhs.uk/our-work/cancer-diagnostics/aspirant-cancer-career-education-development-programme> I am also lead author for the Health Education England (HEE) End of Life Care Learning Outcomes and have developed the HEE Advanced Clinical Practice credential for Palliative and End of Life Care for the national Centre for Advancing Practice (for publication April 2023).

To achieve success, my work and these projects have required effective collaboration, negotiation and teamworking skills across government, charitable and health organisations, and engagement with different health professions. As an EONS Board member, I would bring my significant national and strategic expertise, creativity and teamworking to promote careers in cancer care and develop the cancer nursing workforce.
